RULES AND CONDITIONS

- 1) Cavies will be judged in accordance with the standards and general Show Regulations as provided by the ANCC.
- 2) One Cavy per handler.
- 3) Separate Entry Form must be completed by each Exhibitor.
- 4) Best of Breed will be awarded at the Judge's discretion.

- 5) People are not to leave the Pavilion early unless special permission is sought from the Show Manager. Cavies should not be removed from the Pavilion before 4.00 p.m.
- 6) Sick or lice infested Cavies will be removed from the Pavilion.
- 7) Cavies are not to be fed while judging is in progress.
- 8) No speaking at the Judging Table, either to your neighbour, or the Judge, unless the Judge speaks to you.
- 9) No one to go behind the judging table while judging is in progress.
- 10) All Cavies, apart from long hairs, must be shown on carpet squares. Long hair Cavies should be shown on a cushion/board suitable for their breed.
- 11) The Judge may order any person or Cavy from the competition for bad conduct of one or both.
- 12) The selling of Cavies at the Show is not permitted.
- 13) Cavies purchased from a Judge, cannot be exhibited under that Judge, until the expiration of 3 months, from the date of purchase.
- 14) All Cavies exhibited at a Show must be entire (nor be de-sexed). Any Cavy found not to be entire will be disqualified.
- 15) The Judge's decision is final.
- 16) Entries will be accepted from financial members of clubs affiliated with the ANCC.
- 17) Cavies must be registered with the Tasmanian Registrar. Interstate exhibitors excepted.
- 18) **NO SUBSTITUTE ANIMALS WILL BE PERMITTED.**
- 19) In addition to any special regulations herein all Exhibitors in this section are subject to the General Regulations for Competitors and Exhibitors of the Royal Agricultural Society of Tasmania, copies of which are available on request from the Society.
- 20) Babies age to be as at day of Show.
