

GENERAL REGULATIONS

CONDITIONS OF ENTRY

By entering this competition, exhibitors agree to comply with these terms and conditions and the rules, regulations and policies of the RAST ('Rules'). Upon submission of an entry, the exhibitor agrees to be bound by the Rules and to ensure that his or her family, invitees and agents also comply with the Rules and follow all directions of Ground Staff during the competition.

The Royal Agricultural Society of Tasmania ('RAST' or 'Society') reserves the right to accept or reject any entry without assigning any reason. Exhibitors entering their horses do so entirely at their own risk, and it is a condition of entry that no liability of any kind attaches itself to the Society, its Council Officers, Officials or Members in any respect whatsoever, other than the liability for refund of entry fees in the event of abandonment of any competition.

Where an exhibit, exhibitor and/or an agent fails to comply with any of the Rules, RAST may impose one or more of the following penalties on them: (d) disqualification; (e) suspension; (f) a fine; (g) order the exhibit or the exhibitor, his or her family, invitees and agents be removed from the showgrounds; or (h) any other penalty. Without limiting the above, RAST may forfeit an award.

COMBINING OF CLASSES

Should special circumstances arise, the RAST reserves the right to combine classes, vary conditions and alter classes as it sees fit. The judge will also have the right to transfer entries from one class to another.

SUBSTITUTION OF HORSES

Riders are to be aware of the following EA regulation:

EA General Regulations Article 116.8 – an athlete may withdraw any or all of his/her horses from a competition, but may not add a horse that had not previously been entered for that competition without the approval of the Organising Committee or the Ground Jury.

MEMBERSHIP ELIGIBILITY

Exhibitors entering in PONY CLUB Classes must be a current financial member of their nominated club and have current PCAT insurance.

RIDER AGE – as from 1st January – all classes

Age of rider is as at 1st January in the year of competition as per PCT rules.

PROTESTS

Protests may only be made by exhibitors with exhibits in the class to which the protest relates. Exhibitors may enter a protest by lodging it in writing at the RAST site office within 1 HOUR of the completion of the event to which the protest relates. Protests must be accompanied by a deposit of \$50. The RAST Rules and Protest Committee will consider the protest as soon as practicable and will advise the exhibitor of its decision. If a protest is upheld, the deposit will be returned to the exhibitor. The decision of this committee is final.

JUDGE'S AUTHORITY

Judges may send off a horse which, in their opinion, is unfit to be entered in the class being judged.

Exhibitors are not to approach any judge without prior approval from that judge's steward, the Chief Steward or the Ringmaster, except as required by the judge during the conduct of a class.

ACCEPTABLE ATTIRE

Riders must present in full Formal Pony Club Uniform for the club they are representing, including correct Club Saddle Blanket. Horses are to be plaited as per official PC event requirements.



SADDLERY

All saddlery and gear must be suitable, safe and properly fitted.

Bearing reins, balance reins, draw reins, running reins or similar devices are not permitted at any time on the showgrounds.

SWABBING

Random swabbing may be undertaken during the show, conducted in accordance with RAST requirements. It is a condition of entry you comply with any swabbing request.

SUBSTITUTION OF HORSES

An exhibitor may withdraw any or all of their horses from a competition but may not add a horse that had **not** previously been entered for that competition without the approval of the Committee.

HORSE CONTROL

Any horse which in the opinion of the Chief Steward is not under adequate control will be sent off the arena.

No STALLIONS permitted on Pony Club day as per PCT ruling.

REFUNDS

Entry fees will not be refunded other than in exceptional cases and where a veterinary certificate is supplied. A refund, less 25% administration fee, will be at the discretion of the Equestrian Committee. All applications under these conditions must be received at the RAST office by Tuesday of the week following the Royal Hobart Show. This ruling will not apply where entries are not accepted by the RAST.

PLACINGS

RAST ribbons will be awarded as follows, at the Judge's discretion, for placings in individual classes: 1st - Blue, 2nd - Red, 3rd - White, 4th - Yellow

All first place winners are eligible for the relevant Champion award within their section, unless otherwise stated in the class listings. At the Judge's discretion, the exhibit that is placed second to the selected Champion in its qualifying class is may be eligible to be considered for Reserve Champion.

HORSE AGE

The age of horses is to date from 1 August in each year. Every horse foaled before 1 August in any year shall be deemed to be one year old on that date.

MANURE

All manure is to be picked up from horse area and yards. Failure to do so may result in a fine to the exhibitor.

HORSES ON THE ARENA

Only those horses competing on the day are permitted on the arena while events are underway.

CLASHING CLASSES

Some classes may be run concurrently and may clash. Due to time restrictions on the day we may not be able to accommodate for clashing classes.



DEFINITIONS

Novice: Not to have won First Place at any Agricultural Show

Open: Open to all horses in that height section

Master: Horse has been retired from racing prior to October 2022 (over 2 years)

Newcomer: Open to horses retired from racing since October 2022 (2 years and under)

LEADING REIN

3 years to 7 years. Snaffle bridle only. Attendant must affix the leading rein to the noseband, the reins should go directly to the child's hand, string not permitted, or any aid fastened to the saddle to keep the pony's head in position. No spurs or whips, handler may carry a cane. Riders should at least be able to rise to the trot. Ponies must not exceed 12hh.

DOGS

Dogs are not permitted. This will be strictly enforced.

OFF THE TRACK SERIES

Open to all registered Thoroughbred and Standardbred exhibits that were bred for racing, or have raced, or barrier trialled. Race name must be supplied on entry together with ASB Numbers. Documentation verifying eligibility must be provided on request. Stallions not eligible.

ANIMAL WELFARE

No cruelty will be tolerated. Exhibitors must familiarise themselves with the RAST policies which can be found at https://www.hobartshowground.com.au/policies

COLLECTION & USE OF PERSONAL INFORMATION

The Society collects personal information from exhibitors in competitions conducted by the Society. Verification of the accuracy of this data may be obtained through contact with the RAST. This information is used only for the purpose related to the conduct of the events run by the Society and is not divulged to third parties. However, entrant's names and contact details may be released to duly authorised parties in respect to matters of animal health and safety. The names of exhibitors may be included in catalogues published by the Society and successful exhibitors' names released for general publication. If you do not provide the information requested on the competition entry form, we may not be able to accept your entry.

Section A - Supplier's statements about risk and duty of care

Royal Hobart Show (together the Suppliers) advise as set out below.

The handling of animals is a dangerous recreational activity as animals can act in a sudden and unpredictable way, especially when frightened or hurt.

Participation (including passive participation) in animal handling and/or physical competitions and/or Events at an agricultural show and/or use of the Suppliers' facilities contain elements of risk, both obvious and inherent.

Physical competitions and activities, Events and use of the Suppliers' facilities are all dangerous recreational activities. This document is a risk warning for the purpose of Division 5 of the Civil Liability Act TAS 2002. This risk warning is given by or on behalf of the Suppliers.

This document acts as an exclusion of liability under Division 5 of the Civil Liability Act (TAS) 2002 if the services supplied by the Suppliers are supplied without reasonable care and skill.

Section B - Participant's acknowledgements

By signing this document I acknowledge that:

- 1. Participation in the Event and/or use of the Suppliers' facilities is a recreational service for the purposes of section 139A of the Australian Competition and Consumer Act (Cth) 2010 and a recreational activity for the purposes of Division 5 of the Civil Liability Act (TAS) 2002.
- 2. I participate in the Event and/or use of the Suppliers' facilities at my own risk.
- 3. Participation in the Event and/or use of the Suppliers' facilities is a hazardous activity and involves a significant risk of physical harm and may result in injury, loss, damage or death to me and others.
- 4. Participation in the Event and/or use of the Suppliers' facilities requires certain skills and experience. I declare that I have sufficient skills and experience to be able to safely and properly participate in the Event and/or use the Suppliers' facilities.
- 5. Animals can act in sudden and unpredictable ways, especially if frightened or hurt, or if exposed to loud or unfamiliar noises.
- 6. The Event will be held in close proximity to rides and large groups of people and there may be loud and unfamiliar noises which can frighten animals used in the Event.
- 7. If the Event is held outdoors, there are risks to me as a result of the weather conditions, including either extreme hot or cold weather, rain or wind.
- 8. Insects or other animals may cause animals used in the Event to become frightened and act in an unpredictable way.
- 9. In handling animals, there is a risk of suffering injury including injuries caused by the animals.
- 10. I am responsible for ensuring that I have and will wear equipment suitable for my safety in my participation

- of the Event and/or in using the Suppliers' facilities.
- 11. I am responsible for the condition of any tools and equipment and ensuring that they are appropriate for the Event and/or in using the Suppliers' facilities.
- 12. I use the Suppliers' facilities, including for the Event entirely at my own risk, as I find them and with the prior acceptance of the risk of possible danger to me, both obvious and inherent.
- 13. At the time of participating in the Event and/or in using the Suppliers' facilities, I will not to any degree be under the influence of alcohol or illicit drugs.
- 14. I will not consume any alcohol or illicit drugs while participating in the Event and/or in using the Suppliers' facilities and agree that such use may result in my being excluded from the Event and/or from using the Suppliers' facilities with no entitlement to any refund of money paid to the Suppliers for entry.
- 15. I agree to be bound by the rules and guidelines of the Suppliers as varied from time to time.
