SHOW REGULATIONS

Entries in the Dairy Cattle competition must be received at the RAST's Administration Office, located at Hobart Show Grounds, 2 Howard Road Glenorchy 7010 by no later than 5.00pm on the nominated entry close date. All fees must accompany entries, along with the cattle health statement forms and waiver forms. These forms can also be found on the RAST website. The onus is entirely on the Exhibitor to submit particulars on time.

GENERAL RULES AND REGULATIONS

All Exhibitors when signing of entry form, you are agreeing to abide by all rules and regulations, the RAST condition of entry to Hobart Show Grounds can be found on RAST Website or by contacting the RAST office for a copy.

- All Exhibitors and their handlers, all Young Paraders and Young Judges must sign a waiver form. If under the age of 18yrs forms must be signed by parent/guardian. These forms can be submitted with your entry or passed to chief steward.
- No Alcohol to be consumed in shed between 9am and 5pm.

PERSONAL INFORMATION & PRIVACY

The Royal Agricultural Society of Tasmania (RAST) collects personal information from exhibitors in competitions conducted by the Society. Verification of the accuracy of this data may be obtained through contact with the RAST. This information is used only for the purpose related to the conduct of the events run by the Society and is not divulged to third parties. However, entrant's names and contact details may be released to duly authorised parties in respect to matters of animal health and safety. The names of exhibitors may be included in catalogues published by the Society and successful exhibitors' names released for general publication. If you do not provide the information requested on the competition entry form, we may not be able to accept your entry.

EXHIBITION CATTLE

Applications must be to the Society no later than the closing date for Cattle entries, & consideration will only be given for exhibits which are not eligible to compete in general classes, provided sufficient room is available in the Cattle Pavilion.

SUBSTITUTES

Entries may be substituted in the same class as entry previously received. Stewards must be notified of any changes.

TRUCK & VEHICLE PARKING

Parking for Trucks and floats/trailers will be available on site with entry off Howard Road, Glenorchy. Parking is limited and there must be a 5-meter road clearance for emergency vehicles.

ARRIVAL & DEPARTURE OF EXHIBITS

All exhibitors are to comply with the nominated arrival and departure times- departure time will be from 2pm. Packing up time will be from 12noon. Priority will be given to Exhibitors that have the furthest to travel and a departure timetable will be displayed on exhibitor message board in beef cattle pavilion. No vehicles will have access to shed before 2 pm. All stock must be penned by Wednesday night of show week.

SHOW REGULATIONS

- Entries in Group Classes may be drawn from General Classes.
- NO ANIMAL ALLOWED TO COMPETE IN MORE THAN ONE CLASS UNLESS SPECIALLY PROVIDED FOR.
- All animals must be reg. in accordance with the rules of a recognised Society & satisfy the requirements of the RAST & breed inspector.
- The age of Dairy Cattle to be calculated as from 1st July. Ages as shown in individual classes are all inclusive dates. Date of birth must be stated on Entry Form.
- All exhibits in Dairy Cattle Classes are restricted to animals from Herds certified free from Contagious Abortion & Tuberculosis. Any animal which, in the opinion of the Council Cattle Steward or Breed Inspector, is not suitable shall not be exhibited at the Society's Showgrounds.
- Full particulars must be stated on the Certificate of entry, breeding number, colour, pedigree and herd book number, if fixed.
- IT IS A CONDITION OF ENTRY THAT THERE IS A TOTAL PROHIBITION OF THE USE OF HORMONES OR ANY OTHER UNNATURAL SUBSTANCE IN THE PREPARATION OF STUD CATTLE TO BE EXHIBITED AT THE ROYAL HOBART SHOW.
- All bulls 1yr & over to be tied up at night with strong halter & ring-roped. All bulls over 12 months must have a nose-rope attached at all times.
- All polled cattle to be fitted with a neck strap.
- A dehorned animal competing in any of the Dairy Cattle Classes shall not be penalised for the absence of horns.
- Cow or Heifer entered as "in milk" can be transferred to the "in calf" Class if she has not calved prior to judging day, or vice versa.
- Each exhibit must be paraded from time to time as directed by the Society. This rule will be strictly enforced. Any exhibitor who fails to parade his cattle when called upon to do so shall forfeit all prize-money (if any) won by him, & be liable to a fine of \$4 in each case in which the order of Stewards is not obeyed.
- Exhibitors shall to the satisfaction of the Council Steward: (1) Keep each stall allotted to them & their cattle in a clean & proper condition throughout the duration of the Show. (2) Clean out their stalls before 8 a.m. each day. In the event of the Society receiving more entries than can be housed the Society reserves the right to determine which entries will be accepted. Exhibitors of declined entries will be notified and entry fees refunded.
- Straw or sawdust will be the bedding for the Cattle shed and is included in your entry cost.
- There will be no storage space for gear and feed among cattle. An allocated allotment will be put aside for each exhibitor and named these areas are to be kept neat and tidy at all times.

TROPHIES AND SPECIAL AWARDS

MOST SUCCESSFUL EXHIBITOR – WFI Insurance

To the exhibitor gaining highest number of points in Dairy Cattle Classes. Points shall be determined as follows: Champion 2 points, 1st Prize 3 points, 2nd Prize 2 points, 3rd Prize 1 point provided that points as above for any particular class shall be credited to an exhibitor only in the event of his entry competing against one or more entries won by another. No points will be allotted for Grand Champion, Reserve Champion or any prizes awarded additional to those listed above. In the event of a tie, the highest number of 1st Prizes will decide the award.

OVERVIEW

The Cattle Health Declaration is a legal document. Please complete accurately before signing.

Cattle Health Declarations are a way for producers to provide information about the health status of the cattle they are selling. Buyers should ask vendors for a Declaration and use the information provided to determine the health risks associated with the animals on offer.

Some states/territories require testing or certification additional to that outlined in this document e.g. Johne's disease (JD) in WA and for Enzootic Bovine Leucosis (EBL) in Tasmania. Please check the entry requirements for any interstate movements at:

The original of this form is to be attached to the National Vendor Declaration (NVD) form accompanying the cattle, if applicable. A duplicate remains with the vendor; it is recommended the vendor retains a copy of this declaration for seven (7) years.

QUESTIONS 3 & 4: BOVINE VIRAL DIARRHOEA VIRUS (PESTIVIRUS) TESTING

Persistently infected animals can be detected by conducting a pestivirus antigen test. This test only needs to be conducted once in an animal's life. Cattle that test positive in most cases are persistently infected animals. Pestivirus antibody testing may be done to check the pestivirus status of the herd. Dairy cattle may be tested through bulk milk testing. Contact your veterinarian for assistance. Producers who don't know the answer to these questions should tick the 'N' box.

QUESTION 5: JOHNE'S DISEASE TESTING

Note: JD is a notifiable disease, so it is important to answer these questions.

Check test – testing of 50 adult animals in the herd (or all eligible animals in a herd if less than 50 adult animals) biased to increase the probability of detecting infection, tested by (pooled) faecal culture or (pooled) HT-J faecal PCR. An ELISA test is available but is not recommended and also not accepted for entry of cattle to WA.

Sample test – screening of the adult herd or a large representative sample of the adult herd by an approved test (pooled) faecal culture or (pooled) HT-J faecal PCR. See note above for ELISA test.

Herd Environmental Culture (HEC) Check Test (for dairy cattle) – a test of a representative sample of faecal material from the yard (see JD in [Cattle Definitions & Guidelines](#) for details). Details are available at www.animalhealthaustralia.com.au/jd-cattle-tools.

QUESTIONS 6 & 7: JOHNE'S DISEASE

Occurrence of JD refers to clinical disease in the herd or on the property(s). Clinical disease is an infected animal with chronic diarrhoea and weight-loss that does not respond to treatment.

The **Johne's Beef Assurance Score** (J-BAS) is a voluntary tool developed for JD risk profiling. Details are available at www.animalhealthaustralia.com.au/jd-cattle-tools. The J-BAS is an initial guide and purchasers should ask for more information about JD in the origin herd (see the JD in Cattle Biosecurity Checklist on the 'JD in cattle' webpage). The *National Farm Biosecurity Reference Manual - Grazing Livestock Production* provides a template to use for the property biosecurity plan. All plans should include the JD in Cattle Biosecurity Plan Checklist.

The **Johne's Disease Dairy Score** (JDDS) is a voluntary tool for JD risk profiling in dairy cattle. Information is available at www.dairyaustralia.com.au/bjd

Grazing of non-bovine species – Buyers of cattle from this consignment may consider the grazing of other JD-susceptible species (sheep, goats, alpacas) on the source property as important to their risk-management decisions. These buyers are entitled to seek information on how you have managed disease risks for all your livestock.

TREATMENTS & VACCINATIONS

Provide details on any cattle treatments in the last six (6) months and vaccinations within the last twelve (12) months.

Some manufacturers include more than one of the categories listed in the same vaccine, known as a combination vaccine. If you use a combination vaccine, each agent(s), as appropriate, should be detailed.

For vaccinations to be current, you must have followed the manufacturer's recommendation for vaccination. Typically, young animals or first time vaccinated animals need two (2) doses, followed by annual boosters. As variations to this general rule do occur (e.g. Silirum is given once only), you must use the manufacturer's recommendations.
