AGB INC. SHOW RULES

Australian Goat Breeders Inc. version August 2023

AGB Inc. Show Rules for general information

1. ELIGIBILITY

(i) Exhibitors

Exhibitors entering an Australian Goat Breeders Inc. (hereafter AGB Inc.) Show must hold current membership with AGB Inc. as at the close of entries.

(ii) Exhibit registration

Exhibits entering the show must hold current and up to date registration with AGB Inc. as at the date of close of entries. Unregistered animals are not eligible to enter. Animals must meet the AGB Inc. breed requirements detailed in point 3 below. A copy of the registration certificate must be presented at check-in. Exhibit must be owned or leased by the Exhibitor.

(iii) Exhibit Bio-security

All animals entering a AGB Inc. Miniature Goat Show must be from a CAE and JD whole tested herd. Exhibits must meet the testing rules as per point 3(iv) of these Regulations and must not have been in contact with any other untested animals. Testing documentation forms part of the Application for Entry.

2. APPLICATION FOR ENTRY

Entry comprises completed and signed AGB Inc. Entry Form; proof of CAE and JD testing as per AGB Inc. Bio-security rules; and payment of prescribed entry fees. Entries close on the Friday 5pm, two weeks prior to the show date unless otherwise noted. Late entries and applications not meeting Entry criteria will not be accepted.

3. EXHIBITS

(i) Age

The age of the animal is calculated at the day of judging. Animals can enter only one age class.

(ii) Breed

Animals are only eligible to enter ONE breed type section classes – that is the breed type listed on their registration. Note that each breed standard has a maximum height. Check the issue date of these rules as the Breed % rules are updated annually in line with our program of breeding toward purebred status.

NIGERIAN DWARF

- Exhibits with DOB up to 30/6/2023 must be DNA verified proven to minimum 25% Nigerian Dwarf.
- All exhibits with DOB from 1/7/2023 must be DNAPV to minimum 50% Nigerian Dwarf.
- Bucks with DOB from 1/1/2024 must be DNAPV to minimum 93.75% Nigerian Dwarf (Purebred Status).
- Does + Wethers with DOB from 1/7/25 must be DNAPV to minimum 87.5% Nigerian Dwarf.
- Does not exceeding 57cm. Bucks not exceeding 60cm. Wethers not exceeding 60cm.

PYGMY

- Exhibits must be DNA verified proven to minimum 25% Pygmy unless holding Special Merit.
- Bucks born from 1/1/2024 must be DNAPV to minimum 70% Pygmy (Purebred Status).
- Does + Wethers with DOB from 1/7/25 must be DNAPV to minimum 50% Pygmy or holding Special Merit.
- Does not exceeding 57cm. Bucks not exceeding 60cm. Wethers not exceeding 60cm.

AUSTRALIAN MINIATURE

- Animals carrying more than 25% imported genetics are not eligible to show as Australian Miniature.
- Bucks with DOB from 1/1/2024 must be Purebred or Potential Purebred (max 6.25% IG).
- Does + Wethers with DOB from 1/7/25 must be A Grade or Pot A (max 12.5% IG).
- Does not exceeding 57cm. Bucks not exceeding 60cm. Wethers not exceeding 60cm.

MINI NUBIAN

- A goat holding current registration as a Miniature Nubian and demonstrating breed type.
- Does not exceeding 65cm. Bucks not exceeding 75cm. Wethers not exceeding 75cm.

AGB INC. SHOW RULES

(iii) Identification

Exhibits entering AGB Inc. Goat Shows must carry permanent identification as listed on their entry form and registration papers. Goats must be tagged with approved NLIS ear tag, or tattoo unless providing a written ear tag exemption. Goats may enter with microchip identification. The name of the breeder or stud should not be visible on the animal equipment when in the show ring.

(iv) Measurement

Animals aged over 12 months are to be measured at time of check-in. Any animal not obviously within the appropriate height standard must be taken to a solid, level surface and measured using approved set of show bars and/or measuring stick held by each State Show Manager. Animals measured will be in show stance with head directly out from body and all four legs set squarely underneath, taken at the highest point of the withers, perpendicular to the front leg, no further back than point of elbow. Handler's hand on collar only. Animals over the specified show height for their breed will be disqualified from that show.

(iv) Bio-security

AGB Inc. shows should be conducted following best practice bio-security at all times. The penning area and show ring must be sectioned off, and no member of the public is permitted enter or to touch any exhibit. Animal unloading should be done in a clean, dedicated area. Ag Show provided spaces and pens should be disinfected before animals arrive.

CAE/JD TESTING REQUIREMENTS

- AGB Inc. members and all exhibitors agree to annual whole-herd testing for CAE and Johne's Disease, and understand this is a requirement to participate in any show hosted by AGB Inc.
- For animals to be eligible to enter a show, exhibitors must provide current testing showing the animal by name. A copy of the laboratory report, or letter from a vet detailing the animals tested and individual results including the name of the lab and report number is acceptable.
- Animals over 12 months of age on the day of the show, must have tested clear for CAE and Johne's Disease within 12 months of the date of the show.
- Animals under 12 months of age on the day of the show that are not tested require test results from both parents. If the sire is via imported semen straw, then only dam test required.
- Any positive or inconclusive results in the herd test please supply clear retest Elisa for CAE and clear faecal for JD.

BIOSECURITY - CONTACT WITH UNTESTED/UNKNOWN STATUS ANIMALS

- All goats in the herd entering the show must not have been in contact with ANY untested animals (including goats, sheep, alpaca, llama, cattle, deer, camel). Contact is within 2 metres unless separated by a solid wall where no fluids or faeces could travel under or over.
- Goats in contact with untested animals, or that have not been conducting annual whole-herd testing, will need to provide two clear whole-herd tests with a 6-month interval to be eligible to show with AGB Inc.
- Goats that have entered a show or display where there are untested goats or goats that are not from a whole-herd tested stud, will be deemed as having been in contact with untested animals.

(v) Health & Welfare

Exhibitors are responsible for the safety, health and welfare of all animals in their care. Animals must be penned at all times not being shown under shelter with clean water and access to food. Exhibitors will ensure their goats are kept comfortable throughout the show and during transportation. Goats that are more than 4 months pregnant are not eligible to enter AGB Inc. shows.

Unregistered kids not entered in the show may attend as long as they meet the show testing requirements and are included on the exhibitor waybill.

Any goat that is ill on arrival or becomes ill during the show including scouring will not be permitted to enter the ring and should be returned to the owner's trailer (weather permitting). A vet may be engaged by the Owner or at the direction of the Steward where an animal becomes seriously unwell.

(vi) Photography

Exhibitors agree to stand animals for official photos (generally Best of Breed and Best in Show Awards) for show results at the direction of the Show Manager or Photography Steward. Both Official and general show photos featuring Exhibitors (including minors) and Exhibits may be used in any way by AGB Inc. including promotion of shows and events, on AGB Inc. or related websites and social media platforms. Photographers must not impede the running of the show.

4. EXHIBITORS

- Exhibitors are responsible for completing all paperwork correctly and advising the Steward immediately after check-in of any errors or omissions in the catalogue.
- Exhibitors should wear an AGB Inc. show shirt, or plain black collared shirt in the show ring and for any photos. Dark blue, denim or black pants or knee-length shorts or skirt that is not ripped or faded can be worn in the ring, with enclosed shoes or boots. Exhibitors without enclosed shoes will not be permitted in the ring.
- Exhibitors and their families must follow all bio-security measures as instructed by the Show Manager/Steward.
- Only Exhibitors and Officials are permitted within the Show Ring, marshalling and pen bio-security area.
- Exhibitors should conduct themselves in a professional, and sportsmanlike manner, at all times when attending AGB Inc. events and shows. Mobile phones should be switched to silent during showing.
- Exhibitors should have set-up and unloaded their animals PRIOR to the check-in time. Late arrivals may not be able to be accommodated, and in some cases will not be permitted to unload animals depending on the Show Society entry and exit times.
- Exhibitors are expected to participate in set-up, and/or break down and clean-up of show infrastructure at the direction of the Show Manager or Steward.
- Exhibitors may not identify their animals or stud name in any way in the ring or marshalling area. Stud signage is permitted in the penning area this must not be visible to the judge before/during judging. After the show has ended, exhibitors can display signage at their pens and wear stud branded clothing.

5. SCHEDULE OF CLASSES

Members can view the schedule of classes in the members area of the AGB Inc. website.

6. SHOW PROCEDURE & AWARDS

- Upon arrival Exhibitors will unload their animals as per the instruction of the Show Manager or Steward. Exhibitors will maintain the integrity of the bio-security area at all times. Ensure your animals are comfortable with water, food etc before proceeding to check-in.
- After unloading present your completed paperwork (and any outstanding payment) to the Show Manager or Steward at the check-in area. This includes your signed entry form, waybill, national goat health statement, exhibit registration papers and any other items required for the specific show. At this time, advise Show Manager or Steward of any withdrawals.
- Present animals for identification and measuring as requested.
- Check the show Catalogue has all your exhibits in the correct classes. Notify the Show Manager/Steward of any omissions or errors so they can be corrected before the show starts.
- Check the show start time and ensure you are in attendance and prepared to start 30 minutes before.
- Animals should remain penned between classes, be sure not to block any walkways with equipment or goats.
- Have your goats ready for their next class and proceed to the ring in a timely manner. Parade goats as instructed.
- No exhibitor may remove an animal from a class once judging has commenced without permission of the Steward.
- Do not remove ribbon or leave the ring until the judge has finished making their remarks.



AGB INC. SHOW RULES

Champion is selected from the first-place blue ribbon winners of the individual classes held in a section.

Reserve Champion is selected after the Champion has been awarded and shall be selected from those remaining, plus the animal that stood second to the Champion in its individual class.

Junior & Senior Division Doe/Buck – the Junior age champions compete for Best Junior, with the runner up selected as per Reserve Champion process. The Senior age champions compete in the same way for Best Senior.

Best of Gender – the Best Junior and Best Senior animal of that gender competes for Best Doe or Buck. The second place-getter to the Best of Gender comes out for Runner-up.

Best of Breed – the Best Doe, Best Buck and Ch Master compete for Best of Breed. The second place-getter to the BOB comes out for Runner-up.

Best Wether of Breed – the Ch Junior and Ch Senior animals compete. The second place-getter to the winner comes out for Runner-up.

Best in Show – each Best of Breed competes. The Runner-up is chosen from the remaining BOB in the ring. **Best Wether in Show** – each Best Wether of Breed, plus the Best Master Wether compete. The Runner-up is chosen from the animals remaining in the ring.

- In classes where there is no competition, placement shall be made by the judge according to the merit of the animal. A judge may withhold placement in any class in which no animal meets the requirements.
- Any animal that has been withdrawn/scratched or disqualified must not be recorded in the total number of animals shown in that class/section, and they are not counted in the show points for that section.

7. CHAMPIONSHIP POINTS & AWARDS

- Show must be sanctioned by AGB Inc Committee to be classified as Points Show.
- At least three individual registered studs, or 40 animals must be entered into a show for it to be a Points Show.
- Members can view points system in Members area.

8. JUDGES & OFFICIALS

JUDGES & JUDGING

- Judges must be qualified Goat Judges and approved by AGB Inc. Committee to officiate at AGB Inc. Shows.
- Judges must review the AGB Inc. Breed Standards and Scorecard and judge accordingly at our shows.
- No person shall judge any animal in which they have a financial interest. Financial interest is defined as:
- Partial or entire ownership of an animal, or have been the breeder, or owner of the animal within 6 months preceding the show.
- It is partially or entirely owned by any immediate family member, including siblings, spouse, children, parents, grandchildren or grandparents.
- The animal is owned partially or entirely by the judge's employer or employee, or any person they have a business relationship with, including co-owning other animals not present.
- Ideally Judges should not preside over more than 2 judging appointments in the same geographic area within a 12-month period.
- Judges should not visit, inspect or discuss any exhibit with an Exhibitor within 3 months of a judging appointment with AGB Inc. They must not accept hospitality or accommodation from an Exhibitor immediately before a show.
- Judges should not refer to the show Catalogue during the show.
- Exhibitors should not speak directly to the Judge in the ring unless spoken to by the Judge. Any communication during the show should be made via the Chief Steward.
- In classes where there is no competition, placement shall be made by the judge according to the merit of the animal. A judge may withhold placement in any class in which no animal meets the requirements.
- Judges must follow good bio-security and hygiene when examining animals including not opening mouths of exhibits, using hand sanitiser between udder class exhibits, not touching under the tail of the animals.
- The Judges decision is final. Once the ribbon has been awarded to the animal it cannot be changed. Disputes regarding placement of animals should not be discussed with the Judge unless invited by the judge for discussion after the show has ended.

AGB INC. SHOW RULES

OFFICIALS

- Show Officials include Show Secretary, Show Manager, Steward, Marshall and any other title nominated and responsible for organising and running shows.
- An Official can be anyone who has a sound knowledge of the AGB Inc. Show Rules, Judges Scorecards, and understanding of how to conduct a show.
- All Show Officials are representing the Association, our members and the breeds and must act at all times with fairness, integrity and kindness.
- Each state or geographic area shall have a Show Secretary appointed by the AGB Inc Committee. Show Secretary must hold a current Working With Children.
- The Show Secretary is responsible for taking the entry paperwork, checking in the exhibits and the CAE/JD testing results, as well as the general bio-security of the immediate show and penning area.
- The Show Secretary liaises with the Show Society or property owner, prepares the Schedule, Catalogue and Results paperwork, supervises the Stewards, appoints the Judge and manages the show funds to reimburse any costs.
- A Show Secretary may appoint a Show Manager to carry out some of the duties for a specific show or shows.
- The Show Secretary will within 4 weeks of a show, complete the show results and forward to the National Show Manager for publication and uploading of Championship points.

9. DISPUTES & COMPLAINTS

- Any dispute should be communicated to the Chief Steward when it occurs and before the end of the show so that it may be resolved on the day. Any disputes or complaints that cannot be resolved on the day should be sent to the AGB Inc Committee Secretary in writing within 7 days of the show (by email). If the dispute involves another member, then the dispute will be handled as per the Association Rules.
- Disputes or complaints pertaining to the ethics and competency of judges, complaints pertaining to the management of the show, or the interpretation of the show rules are to be referred to the AGB Inc Committee in writing within 7 days of the show.
- If disqualification of an animal occurs resulting from a complaint where that animal was awarded Champion or another show points award, then no show points will be awarded for that class.

10. INDEMNITY & INSURANCE

- Exhibitors expressly acknowledge that insurance may not be provided and that when attending AGB Inc. shows or events, and must hold my own Public Liability insurance policy.
- Exhibitors indemnify AGB Inc and AGB Inc's directors, officers, committee members, employees, contractors and agents from any and all claims, loss, demands, liabilities, costs, expenses, charges, responsibility, damages including but not limited to proceedings, actions and suits whether in respect of personal injuries, property damage, financial loss or however arising out of or in relation to or resulting from or in connection with the Member's engagement, attendance, and interactions with AGB Inc and AGB Inc's membership, events, open days, shows, and other activities run by AGB Inc.

For clarity that is two Champion Classes for that gender. This will be reflected in the Catalogue.

Equally, for Mini Nubian section where 5 or more does or bucks are entered, the classes for that gender will be expanded in the Catalogue as per the other breed production animals.

All Exhibitors acknowledge that the Catalogue may vary from this Schedule, and expressly agree to this as condition of entry to this show.
