GENERAL REGULATIONS

CONDITIONS OF ENTRY

By entering this competition, exhibitors agree to comply with these terms and conditions and the rules, regulations and policies of the RAST ('Rules'). Upon submission of an entry, the exhibitor agrees to be bound by the Rules and to ensure that his or her family, invitees and agents also comply with the Rules and follow all directions of Ground Staff during the competition.

The Royal Agricultural Society of Tasmania ('RAST' or 'Society') reserves the right to accept or reject any entry without assigning any reason. Exhibitors entering their horses do so entirely at their own risk, and it is a condition of entry that no liability of any kind attaches itself to the Society, its Council Officers, Officials or Members in any respect whatsoever, other than the liability for refund of entry fees in the event of abandonment of any competition.

Where an exhibit, exhibitor and/or an agent fails to comply with any of the Rules, RAST may impose one or more of the following penalties on them: (d) disqualification; (e) suspension; (f) a fine; (g) order the exhibit or the exhibitor, his or her family, invitees and agents be removed from the showgrounds; or (h) any other penalty. Without limiting the above, RAST may forfeit an award.

COMBINING OF CLASSES

Should special circumstances arise, the RAST reserves the right to combine classes, vary conditions and alter classes as it sees fit. The judge will also have the right to transfer entries from one class to another.

SUBSTITUTION OF HORSES

Riders are to be aware of the following EA regulation:

EA General Regulations Article 116.8 – an athlete may withdraw any or all of his horses from a competition, but may not add a horse that had not previously been entered for that competition without the approval of the Organising Committee or the Ground Jury.

MEMBERSHIP ELIGIBILITY

Exhibitors entering in PONY CLUB Classes must be a current financial member of their nominated club and have current PCAT insurance.

RIDER AGE – as from 1st January – all classes

Age of rider is as at 1st January in the year of competition as per PCT rules.

PROTESTS

Protests may only be made by exhibitors with exhibits in the class to which the protest relates. Exhibitors may enter a protest by lodging it in writing at the RAST site office within 1 HOUR of the completion of the event to which the protest relates. Protests must be accompanied by a deposit of \$50. The RAST Rules and Protest Committee will consider the protest as soon as practicable and will advise the exhibitor of its decision. If a protest is upheld, the deposit will be returned to the exhibitor. The decision of this committee is final.

JUDGE'S AUTHORITY

Judges may send off a horse which, in their opinion, is unfit to be entered in the class being judged.

Exhibitors are not to approach any judge without prior approval from that judge's steward, the Chief Steward or the Ringmaster, except as required by the judge during the conduct of a class.

ACCEPTABLE ATTIRE

Riders must present in full Formal Pony Club Uniform for the club they are representing, including correct Club Saddle Blanket. Horses are to be plaited as per official PC event requirements.

SADDLERY

All saddlery and gear must be suitable, safe and properly fitted.

Bearing reins, balance reins, draw reins, running reins or similar devices are not permitted at any time on the showgrounds.

EXHIBIT NUMBER

Exhibit numbers will be posted to exhibitors on acceptance of entries. Every exhibit whilst in the ring or within a marshalling area must display its exhibit number.

Ridden exhibits are to display their exhibit number either in a correctly fitted breast plate on the exhibit or conspicuously on the rider's left arm.

SWABBING

Random swabbing may be undertaken during the show, conducted in accordance with RAST requirements. It is a condition of entry you comply with any swabbing request.

HORSE CONTROL

Any horse which in the opinion of the Chief Steward is not under adequate control will be sent off the arena.

No STALLIONS permitted on Pony Club day as per PCT ruling.

REFUNDS

Entry fees will not be refunded other than in exceptional cases and where a veterinary certificate is supplied. A refund, less 25% administration fee, will be at the discretion of the Equestrian Committee. All applications under these conditions must be received at the RAST office by Tuesday of the week following the Royal Hobart Show. This ruling will not apply where entries are not accepted by the RAST.

PLACINGS

RAST ribbons will be awarded as follows, at the Judge's discretion, for placings in individual classes: 1st - Blue, 2nd - Red, 3rd - White, 4th - Yellow

All first place winners are eligible for the relevant Champion award within their section, unless otherwise stated in the class listings. At the Judge's discretion, the exhibit that is placed second to the selected Champion in its qualifying class is may be eligible to be considered for Reserve Champion.

HORSE AGE

The age of horses is to date from 1 August in each year. Every horse foaled before 1 August in any year shall be deemed to be one year old on that date.

MANURE

All manure is to be picked up from horse area. Failure to do so may result in a fine to the exhibitor.

HORSES ON THE ARENA

Only those horses competing on the day are permitted on the arena while events are underway.

CLASHING CLASSES

Some classes may be run concurrently and may clash. Due to time restrictions on the day we may not be able to accommodate for clashing classes.

DEFINITIONS

Novice: Not to have won First Place at any Agricultural Show

Open: Open to all horses in that height section

Master: Horse has been retired from racing prior to October 2021 (over 2 years)

Newcomer: Open to horses retired from racing since October 2021 (2 years and under)

Exhibits can be shown in either the Show Hunter OR the Show Horse section. The same exhibit cannot be entered in both sections.

DOGS

Dogs are not permitted. This will be strictly enforced.

OFF THE TRACK SERIES

Open to all registered Thoroughbred and Standardbred exhibits who have raced or barrier trialled. Race name must be supplied on entry together with ASB Numbers. Documentation verifying eligibility must be provided on request. Stallions not eligible.

ANIMAL WELFARE

No cruelty will be tolerated. Exhibitors must familiarise themselves with the RAST policies which can be found at <https://www.hobartshowground.com.au/policies>

COLLECTION & USE OF PERSONAL INFORMATION

The Society collects personal information from exhibitors in competitions conducted by the Society. Verification of the accuracy of this data may be obtained through contact with the RAST. This information is used only for the purpose related to the conduct of the events run by the Society and is not divulged to third parties. However, entrant's names and contact details may be released to duly authorised parties in respect to matters of animal health and safety. The names of exhibitors may be included in catalogues published by the Society and successful exhibitors' names released for general publication. If you do not provide the information requested on the competition entry form, we may not be able to accept your entry.

Best Overall Performed STANDARD BRED

\$500 CASH PRIZE

To be eligible, the exhibit must be foal recorded with a Standardbred or Harness Racing Stud Book in Australia or International and have had at least one race or barrier start. Microchip number must be provided. The competition is open to mares and geldings only. A points system will be calculated on places awarded in classes at the show overall across show horse, show hunter, rider, and pony club classes.

This document acts as an exclusion of liability under Division 5 of the Civil Liability Act (TAS) 2002 if the services supplied by the Suppliers are supplied without reasonable care and skill.

Section B - Participant's acknowledgements

By signing this document I acknowledge that:

1. Participation in the Event and/or use of the Suppliers' facilities is a recreational service for the purposes of section 139A of the Australian Competition and Consumer Act (Cth) 2010 and a recreational activity for the purposes of Division 5 of the Civil Liability Act (TAS) 2002.
2. I participate in the Event and/or use of the Suppliers' facilities at my own risk.

11. I am responsible for the condition of any tools and equipment and ensuring that they are appropriate for the Event and/or in using the Suppliers' facilities.
