



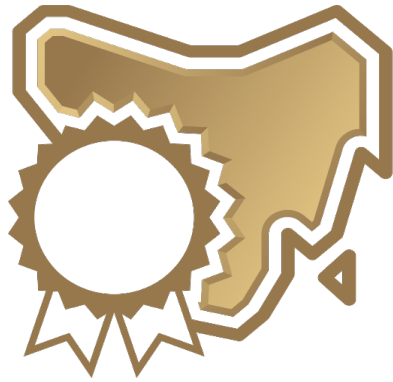

GENERAL REGULATIONS

1. One Cavy per handler at the judging table.
2. Cavies should not be removed from the Pavilion until judging is finished.
3. Exhibitors are responsible for the supervision of their Cavies during the show.
4. Cavies must be penned in suitable, secure carry cages. Cavies must be penned by 8am on 20 October 2024.
5. Sick or lice-infested Cavies will be removed from the Pavilion.
6. No one is to go behind the Judging table while judging is in progress.
7. All Cavies (excluding longhairs) are to be shown on carpet squares approx. 30cm x 30cm or show boards 30cm x 20cm to be no higher than 5cm.
8. All Cavies exhibited at a Show must be entire (not be de-sexed). Any Cavy found not to be entire will be disqualified.
9. Cavies entered in the Baby/Intermediate sections are to be entered by their age as of the show date.
10. The Judge, or immediate family of the judge or a member of the Judges household, or person or people in partnership with the Judge, may not show their Cavies at the Show at which he/she is judging.
11. The Judge may order any person from the competition for bad conduct.
12. **NO SUBSTITUTE ANIMALS WILL BE PERMITTED.**

Additional Conditions (Pedigree Only)

13. Cavies must be pure bred and will be judged in accordance with the standards and general Show Regulations as provided by the ANCC.
14. Placings will be awarded at the Judge's discretion. The Judges decision is final and no discussion will be entered into at the table.
15. No talking at the show table except by the judge or Steward.
16. Cavies purchased from the Judge, cannot be exhibited under the Judge, until the expiration of 3 months, from the date of purchase.
17. Entries will be accepted from financial members of clubs affiliated with the ANCC.
18. No person shall give the judge any indication as to the ownership of an exhibit not already placed in all of the classes for which it is entered and no attempt be made in any way to influence his/her awards.
19. 2 Calls will be given. Animals not at the table at the 2nd call will be scratched. This regulation will also apply to pets.
20. Animals must be on display for public viewing.

In addition to any special regulations herein, all Exhibitors in this section are subject to the General Regulations for Competitors and Exhibitors of the Royal Agricultural Society of Tasmania, copies of which are available on request from the Society.

"All Royal Hobart Show entrants are bound by all policies, procedures, rules and regulations of the Royal Agricultural Society of Tasmania. These may be amended at the discretion of the Board and the Chief Executive Officer of RAST."

Prize Money: All unclaimed prize money will be deemed to be a donation to the RAST if not claimed or, in the case of cheques issued, cashed within 180 days of the issue date.

The Royal Agricultural Society of Tasmania collects personal information from Exhibitors in competitions conducted by the Society. Verification of the accuracy of this data may be obtained through contact with the RAST Section Secretary. This information is used only for the purpose related to the conduct of the events run by the Society and is not divulged to third parties. However, entrant's names and contact details may be released to duly authorised parties in respect to matters of animal health and safety. The names of Exhibitors may be included in catalogues published by the Society and successful exhibitor's names released for general publication. If you do not provide the information requested on the competition entry form, we may not be able to accept your entry.

Section A - Supplier's statements about risk and duty of care

Royal Hobart Show (together the Suppliers) advise as set out below.

The handling of animals is a dangerous recreational activity as animals can act in a sudden and unpredictable way, especially when frightened or hurt.

Participation (including passive participation) in animal handling and/or physical competitions and/or Events at an agricultural show and/or use of the Suppliers' facilities contain elements of risk, both obvious and inherent.

Physical competitions and activities, Events and use of the Suppliers' facilities are all dangerous recreational activities. This document is a risk warning for the purpose of Division 5 of the Civil Liability Act TAS 2002. This risk warning is given by or on behalf of the Suppliers.

This document acts as an exclusion of liability under Division 5 of the Civil Liability Act (TAS) 2002 if the services supplied by the Suppliers are supplied without reasonable care and skill.

Section B - Participant's acknowledgements

By signing this document I acknowledge that:

1. Participation in the Event and/or use of the Suppliers' facilities is a recreational service for the purposes of section 139A of the Australian Competition and Consumer Act (Cth) 2010 and a recreational activity for the purposes of Division 5 of the Civil Liability Act (TAS) 2002.
2. I participate in the Event and/or use of the Suppliers' facilities at my own risk.
3. Participation in the Event and/or use of the Suppliers' facilities is a hazardous activity and involves a significant risk of physical harm and may result in injury, loss, damage or death to me and others.
4. Participation in the Event and/or use of the Suppliers' facilities requires certain skills and experience. I declare that I have sufficient skills and experience to be able to safely and properly participate in the Event and/or use the Suppliers' facilities.
5. Animals can act in sudden and unpredictable ways, especially if frightened or hurt, or if exposed to loud or unfamiliar noises.
6. The Event will be held in close proximity to rides and large groups of people and there may be loud and unfamiliar noises which can frighten animals used in the Event.
7. If the Event is held outdoors, there are risks to me as a result of the weather conditions, including either extreme hot or cold weather, rain or wind.
8. Insects or other animals may cause animals used in the Event to become frightened and act in an unpredictable way.
9. In handling animals, there is a risk of suffering injury including injuries caused by the animals.
10. I am responsible for ensuring that I have and will wear equipment suitable for my safety in my participation

of the Event and/or in using the Suppliers' facilities.

11. I am responsible for the condition of any tools and equipment and ensuring that they are appropriate for the Event and/or in using the Suppliers' facilities.
12. I use the Suppliers' facilities, including for the Event entirely at my own risk, as I find them and with the prior acceptance of the risk of possible danger to me, both obvious and inherent.
13. At the time of participating in the Event and/or in using the Suppliers' facilities, I will not to any degree be under the influence of alcohol or illicit drugs.
14. I will not consume any alcohol or illicit drugs while participating in the Event and/or in using the Suppliers' facilities and agree that such use may result in my being excluded from the Event and/or from using the Suppliers' facilities with no entitlement to any refund of money paid to the Suppliers for entry.
15. I agree to be bound by the rules and guidelines of the Suppliers as varied from time to time.

Section C - Participant's acceptance of risk & no duty of care & waiver of rights

1. I acknowledge and agree that my participation in the Event and any associated activities and/or my use of the Supplier's facilities is dangerous and may have obvious and/or inherent risks as a result of which personal injury (and sometimes death) may occur.
