

## ROYAL HOBART SHOW – 25<sup>th</sup> to 28<sup>th</sup> OCTOBER 2023



- The Kennel Section will be held at the Regatta Grounds, Domain Hobart from Wednesday 25<sup>th</sup> to Saturday 28<sup>th</sup> October, 2023.
- **Entries close on Monday 4<sup>th</sup> September 2023.**
- **Judging commences 9.30 am Wednesday 25<sup>th</sup> – Saturday 28<sup>th</sup> October.**
- Entry for exhibits will be as per map, supplied with tickets – where there is plenty of parking for cars and trailers from **7.00am to 9.00am only. Exhibitors must arrive between the above times.** Dogs must be onsite in the designated Kennel Exhibition Area by 9.00 am and must remain on ground at least until after their Group has finished being judged.
- **Disabled Car Parking spaces will also be available at a cost of \$10.00 per day.**

- **All Parking will be \$15.00 per day ENTRY FEE - \$20.00 per entry – Baby puppies \$10.00**
- **Vans over 2.4 metres in height are required to advise RAST when making an entry (please tick box prior to payment online) so parking arrangements can be made for the extra height.**

**RAST Current Financial Members \$15 per dog if verified by endorsement of RAST membership number. Catalogue - \$10.00.**

**Bitches:** 1a, 2a, 3a, 4a, 5a, 9a, 10a, 11a, 18a

**NOTE:** The age of an exhibit is calculated from the first day of the exhibition, i.e 25<sup>th</sup> October 2023.

A dog may only be entered in one class.

**REGULATIONS PERTAINING TO THE EXHIBITION OF DOGS AND CONDITIONS OF ENTRY:**

To be held under the regulations of the Tasmanian Canine Association Inc., a copy of which may be inspected at the Kennel Show Office. The General Regulations of the Society shall form part of the conditions of entry.

**RETURN OF EXHIBITS FOR GENERAL SPECIALS:**

Exhibitors whose dogs are required to be returned for General Specials must obtain a new exhibit number and new exhibitor's pass. Exhibitors' passes and exhibit numbers are available from the Kennel Section Show Office and it is the responsibility of the exhibitor to collect these prior to leaving the grounds. Exhibitors without the appropriate passes will be charged general admission. Car pass to be obtained at the RAST Office under the Grandstand (fee required is \$15.00 per day)

There will be limited benching, inside the marquee, no Gazebo mats inside the Marquee **only** crates and trolleys will be able to be used, we encourage exhibitors to bring their own Gazebo.

Space will be controlled by the committee and volunteers.
